## Non-Refundable Registration

\$25.00 1st Student

\$20.00 2nd Student

\$50.00 3 or more students per family

Registration and 1st month tuition is due during registration week.

3rd member of family receives 50% off monthly tuition.

If a student takes only a 30 minute, 45 minute or 60 minute class per week you will be required to pay tuition in 3 month intervals.

You will receive a 10% discount if yearly tuition is paid within the first 30 days of enrollment.

Tuition is based upon a 4 week month and will remain the same regardless of the amount of weeks in a month. You will pay the same for 5 week months as those additional classes make up for the holiday break.

There are no refunds for missed classes. Please schedule a make-up class.

## Tuition and Late Fees

Tuition is due the 1st of every month. If tuition is has not been paid by the 15th of the month a late fee of \$15.00 will be assessed.

All Credit card payments will be assessed a 3% processing fee.

All returned checks will be assessed a \$35.00 fee. All returned checks will be reported to Bounceback, a credit collections agency. If payment is made with cash please bring cash to the office to receive a receipt. If payment is made by check and the student's last name is different from the person writing the check, indicate the student's full name, class time, and ID number on the bottom of the check.

## Recital Fee

Recital fee of \$65 per family and is due by October 13, 2017. The fee includes 5 tickets per family. Extra tickets can be purchased for in advance at the studio. Last year we sold out so tickets may not be available at the door, this coming year. If we have them available they can be purchased at an additional cost at the door.

## Costume Fees

\$40.00 Costume fee down payment per costume due by October 20, 2017.

Costume deposit is non-refundable. Remaining balance must be paid by February 16, 2018.

## Private Lessons

Cash only due at the time of the lesson and is to be paid to the studio.

\$35 for solo 45 mins

\$46 for duet 45 mins(\$23 each dancer)

\$51 for trio 45 mins(\$17 each dancer)

## Drop In Classes

If you are interested in attending classes but not on a regular basis (technique only/will not be in recital) you can pay cash for a drop-in class. Only certain classes will be allowed to have drop-in students and different rates will apply. Please speak to the studio for more information.
